## I. ADMINISTRATIVE BUSINESS

2. CPR Committee Report – Trish Kelly presented motions (recommendations from CPR) and Kyla Mallett, Dean, Audain Faculty of Art, gave a summary of the discussion at the CPR meeting in December, where all proposals were approved.

It was noted that the updated program requirement worksheets respond to issues with current forms that were implemented in 2017 when ECU moved from 129 credit degrees to 120 credit degrees. At that time several requirements were cut to accommodate the lower credit count, and allow for flexibility for students. Issues have been arising out of the less structured model and Faculty of Art has reassessed the program requirements for the BFAs in Photography and Illustration. It was noted that ILUS 4XX Illustration Senior Studio is a new course proposal, which provides students with the opportunity to propose and develop a self-directed body of work.

Celeste Martin, Dean, Ian Gillespie Faculty of Design + Dynamic Media gave a summary of the discussion at the CPR meeting in December, where all proposals were approved.

3. Governance Committee Report. Suzanne Rackover reported on the ongoing work of the Governance Committee: developing Terms of Reference for the Senate Executive Committee, reviewing Senate committee composition, especially ex officio and non-voting membership, and ensuring adequate representation from academic leadership on all committees. The Governance Committee will review the Terms of Reference and the membership of the Senate Budget Committee. It was noted that the Senate Budget Committee, which is a Committee of the whole of Senate, reviews and advises on the budget, and the Board approves the budget.

### **III. REPORTS**

1. Vice Chair's report. Dr. Trish Kelly reported that the guidelines and processes for the upcoming Academic program review will be presented to Senate at the next meeting. The Academic office is developing a student survey regarding open elective and putting together a collection of data that will be shared with Senate. A survey for faculty and staff regarding Teaching & Learning needs will be circulated soon. Faculty workshops regarding student pressures, and effective student support will be run by the Counselling office. Dr. Kelly also reported that the unit plans, which build on information in the [Strategic Plan](#), will be uploaded to a software system called Hive.
