INTERNATIONAL STUDENT HEALTH INSURANCE

Newly admitted international students for Fall 2024 will be assessed a one-time \$184.75 mandatory international health care insurance premium. This provides 4 months of health care coverage, until you complete your BCMSP application and are eligible to transition to the mandatory BC Medical Services Plan (BCMSP). For students admitted in Spring 2025, this amount will be \$200.46. Students with access to other temporary health insurance are eligible to opt out of this fee, however you must provide proof of insurance to intadvising@ecuad.ca by August 15th (fall intake) and December 15th (spring intake). GRADUATION FEE

\$85 fee applied to the final term for all Graduating Students.

NOTES

1. LinkedIn Learning Access is paid in the Fall Term only for full year access.
2. ECSU Health Plan applies to all students taking 6 credits and over. It is paid in the Fall Term only for full year coverage. Students can opt out through ECSU.
3. U-Pass BC fees are \$46 per month to eligible students. The fees will increase as of May 1, 2025.
Amount indicated represents a 4-month charge.
4. Additional charges may apply and will vary between courses and/or sections.
5. '22/23 Academic Year and earlier cohort' students are defined as those students who are currently working towards a degree and have enrolled in credit-level courses at ECU in any term up to and including Spring 2023.
6. Students who started credit-level studies after April 1, 2023. Also includes students who paused their studies at ECU and are returning after April 1, 2023.
