International Student Health Insurance		
Newly admitted international students will be charged a one-time \$217.24 mandatory international health care insurance premium. This provides 4 months of health care coverage, until you complete your BC-MSP application and are eligible to transition to the mandatory BC Medical Services Plan (BCMSP). Students who do not have BCMSP in place after 4 months will incur another international health care insurance premium charge the following term. Students with access to other temporary health insurance are eligible to opt out of this fee, however you must provide proof of insurance to intadvising@ecuad.ca by August 15th (for Fall 2025 intake); and December 15th (Spring 2026 intake).
